DEPUTY PRESIDENT

★1. Ms A N Kumbaca (ANC) to ask the Deputy President:

In his capacity as a Special Envoy to South Sudan and leading peace missions on the African continent, what (a) has he found to be the impact of the conflict in Sudan on the peace and stability of the region and (b) measures will South Africa, through the African Union, undertake to bring about peace and stability in Sudan? ★2. Mr L J Basson (DA) to ask the Deputy President:

Considering that the Department of Water and Sanitation recently found that nearly 46% of the Republic's water supply systems are contaminated and that 67% of wastewater treatment facilities are on the brink of collapse, what are the details of the immediate action that the Water Task Team has taken since its establishment to address the critical issues of (a) water infrastructure decay and (b) the shortage of skilled personnel in the water management sector to prevent the potential outbreak of any further health crises such as the tragic cholera outbreak in Hammanskraal? ★3. Mr V G Reddy (MK) to ask the Deputy President:

Whether, in light of the unprecedented and dramatic surge of the incidences of the exchange of fire and fatal shooting between members of the SA Police Service and alleged criminals in the Republic, mainly in the province of KwaZulu-Natal, he, as the Chairperson of the Justice, Crime Prevention and Security Cluster, can take the country into his confidence about any measures that have been put in place to (a) prevent further loss of life and (b) find alternative ways to address such incidences? ★4. Mr S L Dithebe (ANC) to ask the Deputy President:

(a) What progress has been made on the ongoing interventions to address water challenges in prioritised areas and (b) how will he strengthen the outcomes of the Water Task Team in the seventh administration to ensure reliable access to water in such areas? NO376E

★5. Mr J S Malema (EFF) to ask the Deputy President:

Whether he had any engagement with the Minister of Land Reform and Rural Development, Mr M Nyontsho to ascertain the number of Communal Property Associations (CPAs) that are dysfunctional and unable to manage land on behalf of land reform claimants; if not, what is the position in this regard; if so, what (a) quantity of land is currently under the management of CPAs and (b) intervention is he planning to make to empower CPAs to manage land in a manner that is productive and beneficial to other land claimants? ★6. Mr N M Hadebe (IFP) to ask the Deputy President:

With reference to his address at the official opening of the National Conference on the implementation of the Integrated Criminal Justice System Programme and the Review of the Criminal Procedure Act, Act 51 of 1977, (details furnished), wherein he identified the construction mafia as a phenomenon that endangers lives and impedes the Government's objective of transforming the nation into a massive construction site that generates employment and expands the economy, what (a) are the full details of the progress that Government has made to eradicate the construction mafias since his reply to oral question 1 on 28 March 2024 and (b) bearing do these criminal organisations have on the concept of a developmental state that is capable of driving the country's development as envisioned in the National Development Plan 2030?
